Grants Received

Northern Colorado Continuum of Care Receives Additional HUD Funding



HUD recently released their annual Continuum of Care (CoC) funding awards. In United Way of Weld County's first year ever applying for funding through a competitive process, the Northern Colorado CoC was awarded TWO additional projects, bringing the total CoC Award to \$1.45 million (previously at \$1.18 million). Given that the NoCO CoC is only two years old, the significance of this cannot be overstated. There are some CoCs that have been applying for new projects every single year and are never awarded. The NoCO CoC was awarded these funds because of how strong their overall application was.

The "big bet" that Northern Colorado stakeholders made when making the case to the community and to HUD that our region needed to be our own CoC, was that we could draw more dollars into Northern Colorado directly to better address our needs and to help us end homelessness.

That "big bet" has more than paid off: in the first year of being a CoC, we were awarded \$2.3 million in Emergency Solutions Grant (ESG) dollars, in addition to the annual CoC award of \$1.18 million. In the second year, we were awarded two new projects through the Continuum of Care competition bringing the total annual CoC award to \$1.45 million.

According to Kelli Pryor, Director of the Northern Colorado Continuum of Care, "None of this would have been possible without the UWWC board of directors saying yes to UWWC being the Collaborative Applicant."

City of Greeley Community Development Department Awarded DOLA Planning Grant for City-Wide Housing Needs Assessment and Subarea Plan

The City of Greeley Community Development Department, Planning Division was recently awarded a grant for \$187,500 from the State of Colorado Department of Local Affairs (DOLA). Recent legislation, State House Bill 1271 (HB21-1271) created a new competitive grant program for local government projects that exemplify innovative affordable housing strategies. With this grant funding and City matching funds, the City of Greeley will work with a consultant to conduct a City-Wide Housing Needs Assessment and utilize the assessment results to develop a subarea plan with an affordable housing component. Future affordable housing projects within the subarea would be allowed an expedited development review process with reduced development application fees. The City's Long Range Planning and Neighborhood Services team will manage the grant.

Agricultural Manufacturing Tours



JBS Beef Manufacturing Plant - December 2021

The Greeley EHH Department kicked off its series of agricultural manufacturing tours last December with a tour of the JBS Manufacturing Plant. City leaders and representatives from Greeley-Evans School District 6 learned more about our region's largest employer from the local JBS team, led by Director of Operations Celio Fritche. The US Headquarters for JBS (located in Promontory) employs over 1,350 and the Beef Plant (located in east Greeley) employs over 3,250. Their ambition is to make Greeley their flagship operating plant, and a model for safety, best-practices and employee-rewards/morale. Mr. Fritche has built a strong leadership team and looks forward to partnering with Greeley on several initiatives related to community and employee investment.

Vantage is a globally accredited CBD extractor and manufacturer, and one of North America's leading hemp processors. Vantage's world-class 60,000 sq. ft. Greeley facilities located in the High Point Business Park, are purpose-built, safe, and meet pharmaceutical compliance throughout production and manufacturing. During initial development during 2019-2020, Vantage decided on Colorado for its leadership in the industry. Greeley has a rich agricultural history and Vantage wanted the opportunity to grow the hemp industry within the city. The next phase of expansion will create opportunities for training and internships, high-skilled and well-paying jobs, and will likely attract other companies to service the industry.
